- Price should not exceed MRP/Latest price-list of the manufacturer and should be including of all taxes.**
- Quoted rate should be valid for at least 3 (three) months.
- Time of delivery shall be reckoned 14 (fourteen) days from the date of receipt of work order.
- Warranty period** will be considered 2 (two) years from the date of successful delivery of the materials for UPS and 3 years for Supply and installation of Anti Virus. EMD will be released after expiry of three years from the date of successful delivery of the material.
