- EMD –A sum of Rs.1000.00 (rupees one thousand)** in the form of CTS Demand Draft from any Nationalized Bank in favour of University of North Bengal payable at Siliguri is to be attached/uploaded with the tender documents as earnest money deposit, failing which the tender/quotation will be treated as cancelled. EMD will be released after expiry of one year from the date of successful delivery of the material.
- Price should not exceed MRP/Latest price-list of the manufacturer and should be including of all taxes.**
- Quoted rate should be valid for at least 3 (three) months.
- Time of delivery shall be reckoned 14 (fourteen) days from the date of receipt of work order.
- Warranty period will be considered as per manufacturer specification.
- Taxes will be deducted as per Government norms.
- Payment will be made through account payee cheque.
- Price shall be quoted in Indian Rupees (INR).
