- b) **EMD –A sum of Rs.500.00 (rupees five hundred)** in the form of CTS Demand Draft from any Nationalized Bank in favour of University of North Bengal payable at Siliguri is to be attached/uploaded with the tender documents as earnest money deposit, failing which the tender/quotation will be treated as cancelled.
- c) **Price should not exceed MRP/Latest price-list of the manufacturer and should be including of all taxes.**
- d) Quoted rate should be valid for at least 3 (three) months.
- e) Time of delivery shall be reckoned 14 (fourteen) days from the date of receipt of work order.
- f) **Warranty period** will be considered 2 (two) years from the date of successful delivery of the materials for UPS and 3 years for Supply and installation of Anti Virus. EMD will be released after expiry of three years from the date of successful delivery of the material.
- g) Taxes will be deducted as per Government norms.
