- (2) The University will purchase Microsoft volume licence either of English language or all language.
- (3) Taxes will be deducted at source as per prevailing rules of Central and State Government.

- (4) 92% of the total order value shall be released after the successful installation / commissioning of the ordered package(s) against the submission of the test report duly certified by the concerned authority. The remaining 8% of the bill value shall be deducted and kept aside as security deposit which will be paid after 3(three) months from the date of satisfactory activation report, subject redress of complaints, if any.
- (5) Copy of current year PT challan, Trade License, PAN card, VAT / CST registration certificate along with the last challan, Service tax registration certificate shall be accompanied with the technical bid documents. [NonStatutory Documents]
- (6) The vendor shall submit authorization certificate from OEM along with the technical bid.(Non Statutory documents).
- (7) The vendor shall have credential of supply of similar softwares in any University / institution / recognized organization. Copy of credential certificate shall be submitted along with technical bid (Non Statutory documents).
- (8) The Microsoft Licence shall carry 3 (three) years validity with all types of facilities from the date of activation.
- (9) The successful tenderer shall complete the licence activation of the Software within 30 (thirty) days from the date of issuance of the supply order.
- (10) A sum of Rs. 30,000/- shall be deposited to the under noted account of the University through RTGS as earnest money and the copy of receipt challan of RTGS with UTR number shall be accompanied with the technical bid document (Statutory Documents) failing which the tender paper will be treated as cancelled. The earnest money of the unsuccessful quotationer(s) will be refunded without interest after one month of the opening of tender paper and the same of the successful candidate will be refunded without interest after three months of the satisfactory installation of the softwares subject to redressal of complaint, if any.
