- No joint will be allowed in any wire of strand conductor (minimum length is 2 KM).
- The conductor drum with ISI mark will be acceptable only & hall be packed in wooden drum conforming to IS 1778/1980 with latest amendment.
- The length shall be measured in presence of the EIC or his representative(s).
