The provisional admission for the students of MCA Semester-II for the session 2023-2024 shall be opened **from 12.04.2024 (11 am) to 15.04.2024 (11 pm)**.

A student has to attend at least 75% of the classes, tutorials etc. during the period of P.G. (M.A., M.Sc., M.Com., LL.M., M.Lib.I.Sc., M.Pharm.) Semester - II & IV, B.Lib.I.Sc. Semester- II & MCA Semester -II & IV to be eligible to enroll for the semester-end examination.
