Zero Hour

Firstly, The Hon'ble Vice-Chancellor focused on the attendance details. The absence of some members of the Executive Council of University of North Bengal namely Professor Subhas Ch. Roy, Dean, Faculty Council for PG Studies in Science, Sri Siladitya Basu Ray, Special Commissioner, Higher Education Department, The Principal Secretary, Department of Finance, Govt. of West Bengal, Prof. Dyutis Chakrabarti, The Director of Public Instruction, Education Directorate, Principal, Siliguri College, Principal, IILS was noted. Mention was made of Dean, Arts, Commerce & Law who had earlier notified the Vice-Chancellor regarding the delay of his flight and his inability to attend the meeting.

Secondly, the Vice-Chancellor informed the Executive Council regarding the appointment of the Registrar and Finance Officer in the respective posts.

Thirdly, the Vice-Chancellor apprised the Executive Council regarding initiatives taken by the University of North Bengal related to the implementation of the new curriculum and Credit Frame Work for UG programmes and the committee there by formed with Prof. Rathin Bandyopadahyay, Dean, Faculty Council for PG Studies in Arts, Commerce & Law as Chairman so as to explore

possibilities and identify the Higher Educational Institutions including Universities in the State for necessary implementation.

Fourthly, the Vice-Chancellor informed the Executive Council regarding the proposal for centralized admission of all undergraduate courses in all college of the State through the department of Higher Education, Govt. of West Bengal. Dr. Mayukh Sarkar raised certain points regarding the 'tie breaking' formula/subject to be considered in merit calculation, and the list of approved Higher Secondary Board for admission as followed by the University of North Bengal.

Fifthly, the Vice-Chancellor informed the members that despite the willingness of the University to undertake all necessary follow up action including signing of MOU with regard to the setting up of an Institute of Hotel Management in the NBU campus- subsequent to a decision of the Cabinet of Government of West Bengal—no further communication has been received by the University from the Government. He also informed the members that a writ petition in the form of a PIL filled against the University with false allegations on the issue related to the setting up of an Institute of Hotel Management has been dismissed by Calcutta High Court.

 - a. There will be no change in the Summer and Puja Vacation of University teachers as followed in last years.
 - b. Provision for 16 days Summer Vacation is kept in the Holiday list for the affiliated colleges specifically for the teachers other than Hill colleges.

Discussion: It was noted that the Committee met when the University was without a Vice-Chancellor. It was also noted that by recommending no change in the Summer and Puja vacation of the University teachers, the Committee did not take into account that their mandate was to deliberate and recommend "in the light of the proposed NEP as well as the practices followed in other Universities of the State". It was also noted that the Committee has recommended a provision of 16 days Summer Vacation for the affiliated colleges although there was no demand for the same. It was also noted that the two Deans- members of the Committee are not present in today's EC meeting and it is not possible to obtain their rationale and explanation though a decision on the matter is imminent.

Decision: In the backdrop of the above, it was decided to continue with the Summer Vacation for the University teachers only for the year 2023 and that the entire matter be revisited in subsequent meetings of the EC. It was also decided that the provision of summer recess announced through a notification in 2022 for the affiliated colleges specifically for the teachers other than Hill colleges would be applicable for 2023 as well.

ii To consider filling in up of the vacancy in key positions in the administration of the University

Vice-Chancellor pointed out that there are vacancies at various levels in the University including in the teaching as well as in the officer's category. The University is unable to fill in the teaching posts as well as CAS for promotion of teachers to Professors category in the absence of Chancellor's nominee in the Selection Committee. The University could constitute selection committee and take necessary action for promotion of teachers under CAS for positions other than that of Professor where Chancellor's nominee is not required. The Registrar's post is vacant for more than three years and that of the Finance Officer for more than 5 years. Both the posts have been advertised but in the absence of the nominee of the Chancellor in the selection committee, the two posts cannot be filled. However, the University

has sought the nominees and selection committee would be constituted for selection as soon as possible. Vice Chancellor also pointed out that the Estate Officer's post was advertised, interview schedule fixed and then the process was halted. Efforts are now on to fill in the vacancy. It was also noted that recently 5 posts including that of Inspectors of Colleges have been advertised.

Decision: The EC resolved to fill in the advertised posts as early as possible, request for the Chancellor's nominees wherever necessary and the Vice Chancellor should take all necessary action in this direction.

Registrar be requested to follow up.
