Registrar Dr. Nupur Das, Secretary to the Executive Council was present.

Zero Hour

At the outset members of the Executive Council extended hearty welcome to the Hon'ble Vice-Chancellor, Professor Sanchari Roy Mukherjee for joining as Vice-Chancellor of University of North Bengal on 22nd May, 2023.

Prof. Ranadhir Chakraborty, HOD, Department of Biotechnology and Member, Executive Council expressed great concern about the quality of research work. He specifically apprised the Executive Council about the present ranking of NIRF of the University which is not at all satisfactory. He also emphasized that the contractual teacher with more than five years continuous teaching experience may be given the opportunity to guide research scholar. Hon'ble Vice – Chancellor informed the house that the Ph.d Regulation, 2022 which was framed in the light of the UGC Regulation, 2022 shall be again placed before the next Faculty Council meeting for necessary amendments.
